## MINUTES OF CITY COMMISSION MEETING MADISON, FLORIDA DECEMBER 13, 2016

The City Commission met in a regular meeting at 5:30 p.m. in City Hall. Commissioner Rayne Cooks (District 1), Commissioner Ina Thompson (District 2), Mayor/Commissioner Jim Catron (District 3), Commissioner James E. Stanley, Jr. (District 4), and Commissioner Judy Townsend (District 5) were present.

City staff present were: Tim Bennett-City Manager, Lee Anne Hall-City Clerk, Clay Schnitker-City Attorney, Bruce Jordan-Fire Chief, Reginald Alexander-Police Chief, and Efrem Edwards-Police Captain.

The Mayor called the meeting to order.

Commissioner Cooks moved to adopt the agenda; as amended. The motion was seconded by Commissioner Stanley and passed 5-0. (Agenda item #11 "Lift Station / North Florida Community College" was removed from the agenda.)

Commissioner Cooks moved to adopt the consent agenda; as amended: (a) Minutes of November 15, 2016, (b) Minutes of Special Meeting of November 22, 2016, (c) Minutes of Special Meeting of December 6, 2016, (e) Acquisition of Vehicles for Public Works and Wastewater Departments, (f) Declaration of Surplus Items, (g) 2016 Edward Bryne Memorial Justice Assistance Grant, (h) Award of Bid for Electrician Services, (i) Award of Bid for Small Engine Repair Services, (j) Fire/Rescue Department Report, and (k) Police Department Report. The motion was seconded by Commissioner Townsend and passed 5-0. (Consent agenda item #4 (d) "Final Approval of Lease Documents for Police Vehicles; Subject to Final Approval by City Attorney Schnitker" was moved to the regular agenda.)

Commissioner Townsend moved to approve and authorize the Mayor to execute the Ford Motor Credit Company LLC Master Lease-Purchase Agreement for the five new police vehicles; subject to final approval by the City Attorney. The motion was seconded by Commissioner Stanley and passed 5-0.

The Florida League of Cities, represented by Associate Director Carol Westmoreland, awarded Commissioner Townsend with a Years of Service Award for her 20-plus years on the City Commission.

The commissioners awarded a plaque to former Commissioner Marcus Hawkins for his service as a city commissioner.

Commissioner Townsend, acting upon the recommendations of City Manager Bennett and information received from the Madison County E911 Office, moved to deny a citizen's request to rename Safari Drive. The motion was seconded by Commissioner Thompson and passed 5-0.

Commissioner Townsend moved to table taking any further action concerning a contractor's agreement to build four new youth tennis courts at Lanier Field. The motion was seconded by Commissioner Stanley. Motion passed 5-0. It was noted that the FRDAP project remains on hold until the city learns whether the U.S. Tennis Association is going to approve additional funding for the project. Greg Nichols, of Premier Surface Solutions in Tallahassee, is the general contractor for the project and briefed the commissioners about his discussions with USTA concerning USTA's grant requirements.

City Manager Bennett briefed the commissioners concerning a potential lease for a Wastewater Department vactor truck.

It was the consensus that City Manager Bennett and Attorney Schnitker meet to discuss and prepare a recommendation to the commissioners concerning the use of public right of way / sidewalks in front of businesses.

Mayor Catron briefed the commission about a proposed goal-setting workshop. The commissioners, by consensus, agreed to a one-hour session. City Manager Bennett will meet with each commissioner individually ahead of time and review a list of possible goals gathered from department heads and other sources.

Commissioner Townsend moved to close out City of Madison FY 11 Community Development Block Grant, DEO Contract No. 12DB-OH-03-50-02-H12 and authorized moving forward with applying for a new CDBG grant during the next grant cycle. The motion was seconded by Commissioner Cooks and passed 5-0.

City Manager Bennett briefed the commissioners about progress underway in implementing the Florida Department of Transportation's Small County Outreach Program Grant to reconstruct a portion of Range Avenue.

Commissioner Townsend moved to table awarding the bid regarding acquisition of security cameras for the Public Works facility. The motion was seconded by Commissioner Cooks and passed 5-0.

Commissioner Stanley moved to award the bid for remotely-read water meters to Sunstate Meter & Supply, Inc., of Newberry, Florida. The gavel was passed to Mayor Pro-Tem Cooks. Mayor Catron seconded the motion. Motion passed 5-0.

Commissioner Cooks moved to adopt, on second and final reading, proposed Ordinance No. 2016-6 – AN ORDINANCE OF THE CITY OF MADISON EXTENDING THE TEMPORARY MORATORIUM ON IMPACT FEES FOR WATER AND WASTEWATER; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.
